Confidentiality

We strongly recommend parental participation, however all medical records containing information regarding mental health, substance use treatment, and certain medical care such as STD treatment, must be kept confidential by law, just as in your doctor's office.

Bangor SBHC will maintain secure, confidential patient information in an electronic medical record.

Eligibility

- Any Bangor student with a parent/guardian-signed enrollment form on file may use the services of the School-Based Health Center throughout the school year.
- Students who are at least 18 years old, emancipated minors, married, or who live independently, may sign permission for themselves.

Parent Involvement

The School-Based Health Center staff invites parents to be an integral part of a student's health care plan. Parents are welcome to call or make an appointment to come in to the School-Based Health Center with questions or concerns about their child's health or accompany them to a Health Center visit as appropriate. Staff will make every effort to inform parents about their child's diagnosis and treatment when appropriate.



All students at Bangor High School have access to our School-Based Health Center, which provide health care services right in school!

Even if your child has a primary care provider elsewhere, he/she can receive immediate and on-site medical, and mental health care at our center (SBHC). This service is made possible through a program with Penobscot Community Health Care (PCHC). Students do not need to be PCHC patients to use the SBHC in their school. Any student is welcome!

How will this affect my relationship with my PCP

Treatment provided at Bangor SBHC will not take the place of your current primary care provider. Instead, sick children can receive immediate medical care when needed, without the need of the parent to leave work.

If your child does not have a Primary Care Provider, Bangor SBHC will provide that service upon the parent's request.



How would my child make an appointment?

• You can call the health center directly to schedule an appointment

• Should the student become ill during school hours, they should report to the school nurse. The school nurse will refer the student to the Bangor SBHC for further care if needed.



How will I be billed when my child is seen?

The school based health center will bill MaineCare and/ or your insurance carrier for services provided. Copays and/or coinsurance are not due at time of service. Once the insurance carrier has paid the covered amount, you will receive a bill for the portion for which you are responsible.

If your child is uninsured or under insured financial assistance may be available through a sliding fee discount program. The Sliding Fee program provides reduced costs on most services for those who qualify.

Discounts are based on household size and income, in accordance with federal poverty guidelines. An Outreach and Enrollment Specialist can help determine if you qualify.
