The Need

Described by community stakeholders as a leading concern for the community, access to oral healthcare in Waldo County is extremely limited. The median household income in Waldo County is nearly 13% lower than the state average (\$42,221), in a state where median income lags the national average significantly. Affordable dental options are limited to non-existent in the mid-coast area. Without access, oral diseases progress rapidly, becoming emergent and impacting other healthcare conditions.

Our Solution

PCHC is building an 8-chair dental clinic, conveniently located on the second floor of Seaport Community Health Center's new integrated primary care clinic at 29 Schoodic Drive in Belfast.

This new resource – the **PCHC Seaport Dental Center** – is projected to provide critical care through more than 7,200 patient encounters annually, regardless of ability to pay. The clinic will reduce costly reliance on hospital emergency departments to treat dental pain, focus on prevention, and assist private practices in meeting the need in the area.
